**Composition of the General Council under section 16 (2) of HSNC Notification dated 30.10.2019:**

The General Council shall consist of the following members, namely :—

- (a) Chancellor, Chairperson ;
- (b) the Provost ;
- (c) the Vice-Chancellor ;
- (d) the Finance and Accounts Officer ;
- (e) Director Board of Examinations and Evaluation ;
- (f) one Dean to be nominated by the Vice-Chancellor ;
- (g) the Director, Innovation, Incubation, Linkages and Placements ; (h) the Director, Knowledge Resource Centre ;
- (i) three persons nominated by the Provost, out of which one shall be an eminent external expert and two others shall be Principals of constituent colleges, of which one should be a woman ;
- (j) two persons of eminence nominated by Parent Body ;
- (k) two teachers, of which one should be from Scheduled Caste/Scheduled Tribe/ De-notified Nomadic Tribe/OBC/SEBC/EWS, etc. by rotation, who are not principals of constituent colleges, to be nominated by the Vice-Chancellor ; from amongst the teachers of the University ;
- (l) one representative nominated by the State Government not below the rank of Joint Director ;
- (m) one representative from industry and one representative from the research and development sector to be nominated by the Provost ;
- (n) one representative from non-teaching staff to be nominated by the Vice-Chancellor;
- (o) the Registrar of the University shall be a non-voting invitee to the General Council.
